



They're back!! And in full force. The Michigan Department of Natural Resources (DNR) cancelled the Canada Goose Round Up Program for 2023 due to the High Pathogenic Avian Influenza (HPAI) in the State. For more information go to Michigan.gov/AvianInfluenza

DNR strongly recommends AGAINST feeding the geese and swans as it **may** lead to parasitic infections. Infected geese excrement in the lake water may subsequently cause swimmer's itch. See <u>CDC – Cercarial1</u>. <u>Dermatitis</u> for prevention and treatment swimmer's itch.


Did You Know.....

Per Michigan's Watercraft & Marine Safety Act, a

personal watercraft (PWC) is defined as a vessel **less than 16 feet** in length and designed to be operated by a person or persons sitting, standing or kneeling on the craft rather than within the confines of a hull.

A **kayak** is considered a PWC and therefore, for each person on board there must be either a wearable personal flotation device (PFD) or a throwable PFD. DNR has stopped Kayakers on Lee Lake to check for compliance.

All children under 6 years of age must wear a USCG-approved PFD when riding on the open deck of any vessel while underway.



Those born on or after July 1, 1996, may legally operate a motorized boat over 6 horsepower only if they have been issued a boating safety certificate and have it in their possession.

Those **born before July 1, 1996**, may legally operate a boat without restrictions.

Those **less than 14 years of age** may not legally operate PWC (i.e., jet ski, wave runner).
